On the next screen, in the "Message" area (scroll down below the "Send Money" button), please include your name and your Yosemite West address. Click on "Send Money" and you're done. No stamps, no envelopes, no hassle.

## **Yosemite West Becomes the First Mariposa County Community to Complete a Community Wildfire Protection Plan (CWPP)**

At their June 17 meeting, the Mariposa County Board of Supervisors unanimously approved a Community Wildfire Protection Plan (CWPP) for Yosemite West. Yosemite West is the first Mariposa County community to complete a CWPP, which will become part of the overall Mariposa County CWPP that is being prepared by the Mariposa County Fire Safe Council.

The Board of Supervisors' approval was the final step in a process that included approval by Mariposa County Fire Department's Chief Jim Wilson, Cal Fire's Chief Mikel Martin, and Yosemite National Park's Fire Use Manager Michael Beasley.

YWPFI was awarded a grant in 2006 from the National Park Service administered by the California Fire Safe Council to complete its CWPP. YWPFI used this federal funding, and matching funds from the Mariposa County Fire Department and Yosemite West property owners, along with support from its fiscal sponsor, the Yosemite/Sequoia Resource Conservation & Development Council, to complete the vital project.

A CWPP is a planning tool for at-risk communities in the Wildland-Urban Interface (WUI), areas where homes meet with undeveloped wildlands, to identify and reduce the risk of wildfire across the landscape and jurisdictional boundaries. It is developed through a collaborative process that identifies and prioritizes potential solutions, so that when funding is sought to address wildfire issues, there is a comprehensive overall plan from which to start. **A CWPP neither guarantees funding nor regulates actions, but communities with completed plans have a competitive edge for grants for hazard fuel reduction projects.**

Wildfires in California have destroyed homes and entire neighborhoods, garnered national media attention, and created

momentum for the passage of federal and state legislation addressing wildfire risk. A CWPP is a crucial step in communities working to protect themselves.

## **Spring Fire Safety in Review**

### **Memorial Day Weekend Clean-up**

We'd like to extend a special thanks to all the volunteers who braved the cool and drizzly Memorial Day weekend to help with the clean-up efforts: the Chapin family, Harry Hagan, Tom Lambert, John Mock, Ken Owens, Don Pitts, the Ringrose family, Al Ruiz, Bob Skrdla, Ken Wall, and Bob Wolcott.

The picnic moved indoors due to the inclement weather, so our sincere appreciation to Kay Pitts and the YWPFI Hospitality committee for organizing all the food and to Don and Kay Pitts for letting almost four dozen folks crowd into their living room. And, a special thanks to our guest speakers: Paul Alvarez of CalFire; and Sean Rankin and the chipping crew from the Mariposa County Fire Safe Council.

### **2008 Chipping Program**

YWPFI sponsored the 4th Annual YWPFI Spring Chipping Program on June 2-3, 2008. The goal of the program is to facilitate creation of community wide defensible space in compliance with PRC §4291. Twenty-eight property owners of 31 parcels (25 houses and six vacant lots) participated in the program, representing 29% of the YWPFI membership.

### **2008 In-Kind Services Survey Results**

The 2008 IN-KIND SERVICES SURVEY showed that Yosemite West residents invested more than 1,600 hours of volunteer labor this spring

in addition to hiring labor to help with brushing and thinning. The total valuation of Yosemite West's effort toward creating community-wide defensible space is more than \$95,000! We appreciate the time everyone took to complete the survey, which yielded interesting and useful data.

Of the survey's respondents, 83% were homeowners and 17% were vacant lot owners. The average number of hours per parcel spent on hazard fuel reduction and debris disposal was 15 hours, with a range from four to 56 hours.

For the three types of **Hazardous Fuel Reduction**, 100% did brushing of the forest floor (raking pine needles and cones, removing dead/downed wood, and increasing space between shrubs), 70% did thinning (removing dead trees, reducing ladder fuels, and increasing spacing between large trees), and 30% improved access to their driveway and/or parking area. Sixty percent hired someone to help with brushing and thinning, and 13% helped their neighbors.

For the three methods of **Debris Disposal**, 35% piled for the annual chipping program, 13% burned on their own property, and 61% hauled to the community burn pile.

### **Lessons Learned**

From the 2008 IN-KIND SERVICES SURVEY and this year's clean-up efforts, we'd like to share a few points to keep in mind.

- Some residents did hazardous fuel reduction, but no debris disposal. This means that debris was left on the property. **To succeed at creating community-wide defensible space, the debris needs to be removed from the property and the interior of the community.** Raking leaves or hauling debris to the edge of your property does not create community-wide defensible space. YWPHI facilitates debris removal by organizing the Memorial Day weekend clean-up to haul debris to the burn pile and by sponsoring an annual chipping program. Please take

advantage of these free programs, which are part of your YWPHI membership benefits.

**The fire season is underway, so if you still have debris piles, please arrange to remove them now. If you hired someone else to rake and haul your pine needles, please double check that this work was done.**

CalFire suspended all burning in Mariposa County on May 1st. Since then, there have been several "campfires" on private property in Yosemite West. Please note that these are illegal, even on your own property! Be sure that anyone and everyone staying or working at your home knows and understands that we all need to be extra careful in this very dangerous and dry fire season. If you see any open fires in Yosemite West, CalFire requests you to immediately call ☎ 911.

- **The Memorial Day weekend clean-up is not a free service offered by YWPHI; it requires volunteer participation.** Some residents have incorrectly thought that if they raked and piled pine needles but were not present on Memorial Day weekend, someone else would haul their pine needle away. This is incorrect; you must be present and help haul your own pine needles.

- Some residents have defensible space on some or most of their property, but not uniformly on all of it. **Make sure your defensible space encircles your house and equally extends out in all directions, so as to comply fully with PRC §4291.**

- Some residents indicated they piled for the chipping program, but did not sign up for the chipping program. **The chipping program requires advance sign up so the YWPHI Fire Safety committee can tag piles for the chipping crew.**

Our sincere thanks to everyone whose efforts help toward making Yosemite West a Fire Safe community.
