Meeting called to order at 7:03pm, with quorum.

Agenda items:

1) Re-cap of the 5/28/2018 meeting at the NESC and next steps for Henness fire station.

Ted had sent a letter on 5/17/2018 to NatureBridge executives asking for consideration of methods to earmark funding for the Henness fire station. There has not been a specific response from NatureBridge. Sergio suggests we "keep the dialog" and Sergio plans to re-contact NatureBridge. Both Ted and Sergio will make contributions earmarking the Henness fire station and look to see if the designation is acknowledged.

2) Fire equipment and fire-hose lay training

Ted has moved some equipment (fire hoses, valves, nozzles) to the corner of Henness Circle and Azalea. We have contacted the CalFire chief for Mariposa county who was cooperative to discuss scheduling a training. Ted is working this issue to establish relationship and agreement with CalFire, but we may likely postpone to next year.

3) Role of YWPHI in assisting owners to obtain better fire-insurance

Many homeowners have experienced severe fire-insurance rate increases. There might be some benefit to aggregation, but past efforts did not pan out with small insurance companies, so any new effort might need a different tact, such as approaching a large insurance broker like Lloyd's who might assist in "distributing".

Sergio will continue asking his fire insurance broker about what process can improve the ISO rating, including questioning how to actually get effect from any improvements. See: https://www.isomitigation.com/ppc/fsrs/items-considered-in-the-fsrs/
The ISO organization gets information from many sources, including "community surveys", and it is not clear how to affect enough input to actually make a change in ratings.

The criteria for ISO ratings is not just proximity to a fire-station alone, but a weighed formula including categories:

- i. 9.5% on Emergency communications (911 response characteristics, jurisdiction sharing)
- ii. 47.4% on Fire Department (Distance, equipment capacity, staffing, training)
- iii. 37.9% on Water supply (Capacity, redundancy, piping and wells, Hydrant conditions)
- iv. 5.2% on Community risk reduction (Local building codes, enforcement, fuel removal, public safety, fire equipment, volunteer training)

4) YW District Advisory Committee

After years of service, John Mock has passed the chairmanship of the YWDAC on to Tom Lambert. There is currently an opening on the committee, and Ted is applying.

5) Proposal by Brian Bond to purchase Excel-format property ownership data from the county, instead of transcribing from paper.

The access costs \$150 per month, and it is permitted to join just for a single month to get updates. This compares with our current cost of \$60 to get a one-time dump of paper address of property tax data. We agreed to authorize the expenditure at the September meeting in preparation for an end of the year mailing, and perhaps continue to buy the updates for one month each year.

Gary pointed out the need for a more personal touch to welcome new homeowners. This year's new membership mailing may also want to include more helpful

8) Mailbox shed maintenance and enhancement

Every spring, critters and birds (woodpeckers) do damage and make nests in the YWPHI mail shed. We got repairs done this year by Jose, who volunteered the effort without reimbursement (thanks!). An idea to repel critters and birds could be to install a screen door, but this would mean narrowing the 4ft entryway by building a frame to mount a 3ft wide swinging door. After discussion, it was not clear whether this would create more maintenance issues than it would solve, so we will postpone and see if Jose's repairs hold through the next season.
